# Montana-Dakota Utilities Co. Annual Update to the Generation Resource Recovery Rider

Effective February 1, 2025

On November 1, 2024, Montana-Dakota Utilities Co. (Montana-Dakota) filed its application with the North Dakota Public Service Commission (Commission) to update its Generation Resource Recovery Rider (GRRR) rates in accordance with the Company's Generation Resource Recovery Rider Adjustment Rate 56 tariff that states the rates will be revised annually to reflect the most recent projected costs to be recovered.

The GRRR update includes North Dakota's allocation related to the amortization of the Lewis and Clark Unit I and Heskett Unit I and Unit II regulatory asset and other deferred costs and the Financial Incentive related to the Company's Power Purchase Agreement.

On January 8, 2025, the Commission approved Montana-Dakota's Generation Rider rates effective with service rendered on and after February 1, 2025. A typical residential customer using 800 kWh will see an increase of \$0.08 per month or an increase of \$0.96 annually. The GRRR is shown as a separate line item on your bill.

## Montana-Dakota Utilities Co. Annual Update to the Renewable Resource Cost Adjustment

Effective February 1, 2025

On November 1, 2024, Montana-Dakota Utilities Co. (Montana-Dakota) filed an application with the North Dakota Public Service Commission (Commission) to update its Renewable Resource Cost Adjustment (RRCA) rates in accordance with the Company's Renewable Resource Cost Adjustment Rate 55 tariff that states the rates will be revised annually to reflect the most recent projected level of costs to be recovered. The Commission approved the updated RRCA rates on January 22, 2025.

The RRCA rates reflect North Dakota's allocation of Montana-Dakota's investments in its three wind facilities (Diamond Willow, Cedar Hills, and Thunder Spirit) currently not being recovered through the Company's electric service rates, as well as the amortization of the under-recovered RRCA balance through January 2025.

The new RRCA rates will be effective with service rendered on and after February 1, 2025.

A typical residential customer using 800 Kwh will see a decrease of \$1.14 per month, or \$13.68 annually. The RRCA is shown as a separate line item on your bill.
